**The Round Table is planned within sections:**

1. The relationship between national and international law.
2. Collisions in national and international law.
3. Implementation, protection and restoration of violated rights in national and international space.
4. The influence of international law on the formation of the legal system of the state.
5. International institutions for the protection of human rights and freedoms.
6. The role and place of ECHR decisions in the national judicial system.
7. Erga Omnes, or one for all and all for one in the practice of implementing the norms of international law.

Round Table format: distantly on Google Meet platform.

- 10.45-11.00 Connecting participants of Round Table to an online platform.  
11.00-11.30 Welcome speech and discussion of the format of work in sections.  
11.30-16.00 Work of discussion platforms (sections).

***Languages of the Round Table:*** English, Ukrainian, Belarusian.

## REQUIREMENTS FOR PARTICIPANTS IN THE ROUND TABLE:

1. **FILE FORMAT:** abstracts are accepted only in electronic form in the file format MS WORD by **May 15, 2021**. The name of the file should contain the author's last name in Latin letters (for example, «Avramenko»). After sending the abstracts by e-mail you receive a confirmation of their receipt.

2. **MARGIN:** A4 format with margins of 2 cm on each side.

3. **PAPER LENGTH:** no more than 5 pages of text (with bibliography) in the Word editor, font – Times New Roman, point – 12, line spacing – 1,5, paragraph – 1,25.

### 4. REQUIREMENTS FOR THE TEXT DESIGN:

4.1. Location on the page: author's first name and last name (without specifying the degree and title), the name of the institution, city and state should be printed in bold in the upper right corner of a new line, in the middle: e-mail (necessary); below in the middle – the title of the article (**in English and Ukrainian / Belarusian** languages), printed in bold; from the next line is printed the text of abstracts (at the beginning – Relevance and Purpose of this work, presentation of the main research material, at the end – Conclusions and List of Sources).

4.2. Making a List of sources («LIST OF SOURCES»): from the paragraph, without indentation, 14 point, single interval. References in the text to sources – in square brackets (for example: [1, c.12]) according to the list of sources, placed alphabetically at the end of the text.

4.3. In the next line (**in English and Ukrainian / Belarusian** languages), in bold, indicate last name and initials of the author of the thesis, in brackets – name of institution, city, state, author's e-mail, after brackets – theme of thesis.

5. **INFORMATION ABOUT THE AUTHOR MUST** be indicated at the end of the abstract (**in English and Ukrainian / Belarusian** languages): full author's name (in bold); studying place, in brackets – city and state; home address, ZIP-code; working address, ZIP-code; phone number (mobile); e-mail.

**Application, abstracts and information about the author must be in one file.**

6. Authors are responsible for the completeness of the coverage of the studies issues, systematic presentation, the certainty of the facts, links to sources, writing proper names, geographical names etc. Compliance with the requirements for the design of the material is a necessary prerequisite for its inclusion in THE COLLECTION OF MATERIALS OF THE ROUND TABLE. Abstracts are edited by the author.

7. Each participant of the International Student Round Table will receive a certificate of participation.

8. Participating in the International Student Round Table is free.
